## New Business:

1. As a correction to last week's news, the ANA Money show has now been canceled.
2. June 8 - Picnic Meeting is scheduled.
3. Randy made the following announcements:
a. Feb 11, The US mint will begin selling 2021 American Silver Eagles Proofs (old style reverse)
b. March 4, 2021 they will begin selling Silver Proof Sets
c. 1921 Silver Coin bill passed the Senate to issue commemorative 1921 Silver Morgan and Peace Dollar coins.
d. Legislation passed to change the metallic composition of circulating coins.
e. April 18-24 is National Coin Week- "Money, Big and
 BOLD" 100-yrs ago the Mint reintroduced the Morgan Dollar and 50-yrs ago was the introduction of the Eisenhower Dollar.
f. US mint debuted Donald J Trump commemorative medals
g.
