- Coin Show!
- Why this topic?
 - Dealers will be traveling with inventory and cash
 - Attendees may have some pieces, but more cash
 - Coin Show theft is on the rise (declined during early months of COVID pandemic, but back with a vengeance)
 - 2017 article in The Numismatist and continued bulletins from Numismatic Crime Information Center

Where are thefts occurring?

- A. Bourse floor?
- B. Hotel Room?
- C. Parking lot?
- D. Vehicle disabled (side of road)?
- E. Followed to a pitstop?
- F. Followed home?

- 2018 Vancouver, BC show, dealer was followed for 70 miles before being stopped by burglars (believed to be in a South American gang)
- 2019 Kent, WA show, 2 dealers slept in their room(s)
 while \$200K in inventory was taken from their vehicle(s)
- 2019 Anaheim, CA show, followed home to Torrance (almost 30 miles) – entire inventory stolen
- 2019 Topeka dealer had a suitcase taken from his vehicle while loading up to attend the Abilene Gun Show.

- 2021 Walnut Creek, CA show, dealer dropped off coins at hotel, but still had totes in car when going to Denny's for dinner. \$15K-\$20K
- 2022 El Cajon, CA show, dealer stopped at a Starbucks and brought entire inventory in bag into the store, bag stolen by suspects who fled to waiting vehicle – \$100K
- 2022 West Springfield, MA show, dealer was leaving and was the victim of a smash and grab – 2 cases taken
- 2022 Omaha, NE show, dealer went back inside for a few minutes. A foreign object in the door handle or key fob jammer prevented the vehicle from locking. Entire inventory of coins were taken from the trunk.

- 2022 Atlanta, GA show, dealer saw a suspicious individual in the parking lot, so checked their tires. Found a device to puncture the tire down the road. This was removed, but the person followed the dealer home only to not find the car (was put in the garage). Nothing stolen!
- 2022 Richmond, VA show, dealer stopped several miles from the show. Thief(s) gained entry and grabbed.
- 2022 Jacksonville, NC show, dealer drove home several miles from show and car was burglarized at approximately 1:30am (2 day show and dealer left inventory in car overnight)

• 2023 Tennessee State Numismatic Society show, dealer was followed to Cherokee, SC (over 4.5 hours away) where they stopped to eat. 2 males broke into the vehicle and stole cash and coins which were recovered after officer spotted vehicle. A female accomplice was seen at the show and has not been apprehended. Suspects are from Colombia.

What can attendees do?

- Carpool
- Drive directly to show and avoid travel problems
- Be aware of anyone following you
- Don't drive directly home (take the long way)
- Get gas before the show so you don't have to stop for it after
- Go to the bathroom before leaving the hotel
- Have personal protection
- Learn about the show and area around it
- Be alert to and from vehicle (no cell phones)
- Don't tell others if you do stop that you were just at the show

What can dealers do?

- Contact bourse chair to answer any questions such as where to load/unload
- No chatting, texting, or calling while loading/unloading no distractions
- Check security of show look for suspicious people, vehicles, or activity and identify security personnel
- Full inventory list and leave a copy at home
- Secure inventory behind table first before arranging cases, lamps, etc.
- Identify neighbors (especially if you don't have help for breaks)
- Do not let early browsing until you are ready for them (cases closed and can watch them)
- Once setup, take a picture of your table to document your presence
 - Each individual case should have a picture

What can dealers do?

- Do not keep cash with other valuables and lock large quantities (not displayed in case)
- Note emergency exits and develop a plan grabbing what before evacuating?
- Emergency kit with flashlight
- Lock cases until someone asks to see something inside
- Do not let people put things on your case
- Show only one coin at a time to a person and limit number being shown
- Pairs will have one person distract you while the other is working on theft
- Do not turn you back on customers

What can dealers do?

- Be wary of people asking about your travel, value of inventory, or who else rides with you
- Cell phones have a camera capable of recording use it!
- Distractions fainting, heart attack, dropping child, etc.
- Be on the look out for people selling counterfeits
- Taking check check ID (2 forms) and photograph, make sure person matches ID/check, address should match, no postdates
- Cover your cases with a drop cloth if it is visible in car
- When loading your vehicle, coins in last, out first

What can you do inside your vehicle?

- Do not leave valuables in your vehicle
- Bags/briefcases/purses need to not be in plain sight (trunk, under seat, take with you, etc.)
- Lock the door (even when you are in it)
- Don't sit in the parking lot looking at phone or at new acquisitions

What can you do outside your vehicle?

- After the show, take a second and look over your windows for any hand smudges or anything off
- Check your tires for any cuts or low tires (someone let air out)
- Check under the front for radiator fluid (cut hose)
- If you can't drive all the way home on a tank of gas, pay at the pump
- If you need to use the restroom, make sure your vehicle is visible by an attendant and ask them to watch your vehicle
- If you are bumped, don't stop
- If you are carjacked, your life is more important that coins/money/vehicle

What can you do if you are being followed?

- Make an unexpected turn to make sure you are being followed
- Make a second turn to double check
- Third turn confirms it
- Don't drive home at this point
- Drive to the nearest police or fire station
- If you are on interstate, move to the left lane, turn your flashers on, and drive 45 mph until you are pulled over (though your follower should leave you in the dust)
- If you are pulled over by an unmarked car, call 911 to confirm they are a law enforcement officer

Home Protection

- Security System
- Fakes
- Park in garage
- Safe(s)
- Safe deposit box(es)
- Social media brag after trip, not before
- Pick up anything left on door promptly
- Return garbage bins immediately

Personal Protection

- Please, take a conceal carry course if carrying a firearm
 - Constitutional carry allowed in Kansas, but has limitations
- You are responsible for your firearm at all times
- Can you use it in a theft if the robber isn't threatening you (i.e. the briefcase being taken from the Topeka dealer)?
- Research all local and regional laws
 - Kansas is open carry and constitutional carry
 - Sign with firearm and a slash means no open carry
 - Only when there is a metal detector with security working it,
 there is no conceal carry
- Non-lethals (Taser (or knockoff), pepper spray, wasp spray, etc.)

Summary

- Have a good, safe time!
- It is better to be safe, than sorry.
